Founded in 1965, Fresno County Economic Opportunities Commission (EOC) has spent over four decades investing in people, helping them become self -sufficient. The scope of service provided by our Agency consists of nearly all facets of human services and economic development, ranging from pre-school education to vocational training; from juvenile and drug abuse counseling to treatment for serious juvenile offenders; from youth recreation to senior citizen hot meal services; from energy conservation education to crisis intervention; from preventive health care to prenatal nutrition education; and from vocational counseling to job placement services.

Fresno County EOC is a private, nonprofit 501(c)(3) corporation governed by a twenty-four (24) member tripartite Board of Commissioners under the auspices of the EOA of 1964.

Our community action agency operates on an annual budget of approximately \$160 million and employs over 1,300 full- and part-time employees.
