Want to save for your first home, your own business, or college or other job training?

With the Community Financial Resource Center's IDA match savings program, you could receive \$3 for every \$1 you save for your college education or job training, starting or growing a business or buying your first home. You could save up to \$1,000 in your account and receive up to \$2,500 in match money, giving you a total of \$3,500 to invest in your goal!

Am I eligible?

To be eligible for the IDA match savings program, you must be:

- At least 18 years old.
- Reside in the Los Angeles County Area.
- Have a valid social security number or an Individual Tax Identification Number (ITIN).
- Earning income (full-time, or part-time employment, or self-employment)
- Earned income and adjusted gross income (AGI) must be less than:

Earning income is eligible for Earn Income Tax Credit (EITC) on the 2012 Federal tax return

• Have less than \$10,000 in assets, including one automobile and home



- Willing and able to save at least \$50 per month
- Willing and able to attend money management seminars and training on how to reach your goal
 of starting/growing a business, graduating from college/job training, or buying a home.
- If you are eligible for Temporary Assistance for Needy Families (TANF) or the Earned Income Tax Credit (EITC), you may automatically qualify.

Those not selected in the lottery will have access to most other services offered by CFRC.
