AEO Victories in 2013

- AEO's "Micro bill" has been reintroduced
- AEO in Senate Small Business Committee Report on the Wealth Gap in the United States
- TILTForward in House Small Business Committee
- Strong Policy Panel in St. Louis
- AEO meets with Senate Small Business Committee Chair Mary Landrieu
- Support for "WIA Fix" Growing

- * All FY2013 levels subject to a 5% across the board cut, as a result of sequestration.
- ** To date, the SBA's Boots to Business Program has not received funding.
- ** The Senate-passed FY2013 Farm bill contained authorizations for all three rural business development programs. In addition, the bill included mandatory funding for the RMAP program, funding it at \$3 million each year, FY2014-2018.





Expanded AEO Micro Bill Intro'd

- AEO Champion Rep. Cedric Richmond (D-LA) introduced H.R. 2474 "Community Lending and Small Business Jobs Act of 2013" in June
- Bill expands on micro bill originally introduced in 2011
- Rep. Richmond cited AEO's Power on One in Three during his floor remarks





H.R. 2474 – Micro Bill

- Directs repaid funds from SBLF into a new "Small Business Capital Investment Program" for CDFIs to boost small business lending
- Enhance PRIME Program
 - 60% of grants in LMI communities
 - Review application and award process
- Microbusiness Coordinator at SBA
- Youth Entrepreneurship Program at SBA





Trouble Spot: WIA Reauthorization

- WIA expired in 2003, has been extended each year via appropriations bills
- House: SKILLS Act (H.R. 803)
 - passed House in March
 - Consolidates 35 "ineffective and duplicative"
 training programs into one single state block grant
- Senate: Set to begin hearings this week
 - AEO engaged with Senate staff to include selfemployment "fix"





Trouble Spot: WIA Performance Fix

"Our Issue"

- Background: DOL inability to count selfemployment as a successful outcome
- Rep. Capps AEO champion in the House;
 AEO working on finding co-sponsors
- In Senate, support growing: Senators Ron Wyden (D-OR) and Mary L. Landrieu (D-LA)
- Amendment possibility





Trouble Spot: Self-Employment Assistance

- Background: 2012 SEA Expansion under DOL (P.L. 112-96)
- AEO sought extension of application deadline beyond September 2013
- Any extension would require "new" funding





Trouble Spot: Crowdfunding

- Background: JOBS Act of 2012 (P.L. 112-106)
- Crowdfunding would allow small businesses to raise up to \$1 million annually
- Rule was due December 2012, delayed repeatedly
- This week, SEC announced intention to publish proposed rule by September 2013
