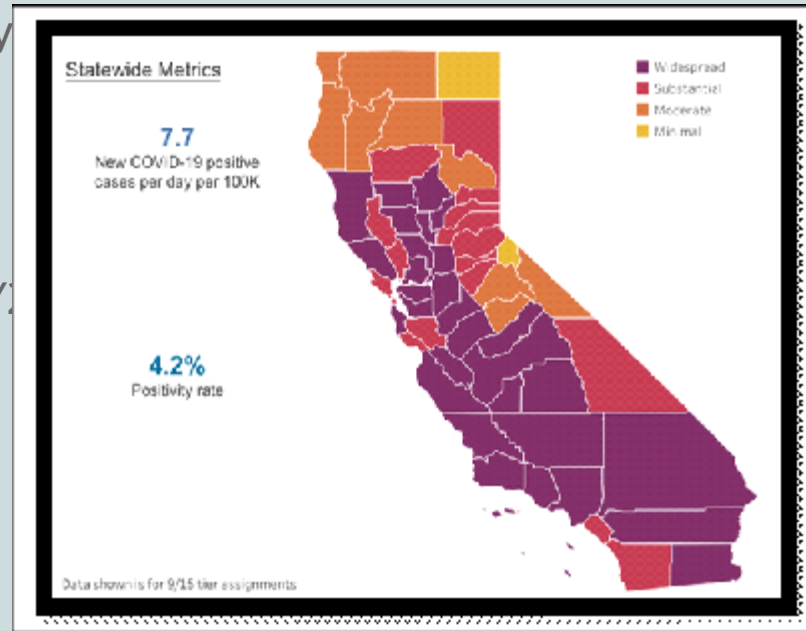
## Federal Update

- This is the state's four tier reopening plan. Tier 4 (purple) has the most restrictions and Tier 1 (yellow) has the fewest.

- Updated Stay-at-Home Order 8/17/20



# State Update – New Programs

- **Social Entrepreneurs for Economic Development**
  - \$10 million initiative
  - California Workforce Development Board
  - economically disadvantaged groups who face significant barriers to employment, including, but not limited to, individuals with limited English proficiency.
- **Small Business Finance Center at the IBank**
  - \$100 million loan guarantee and
  - \$25 million to support California CDFIs and mission-based lender liquidity
- **Disaster Loan Guarantee**

# State Update – California Rebuild Fund



- California Rebuilding Fund, a new program built to support California's smallest businesses
- Flexible, affordable loans to small businesses with 50 employees or fewer through participating community lenders.
- Partnership with public, private, and nonprofit leaders across the state
- CA Rebuild Fund Train-the-Trainer: Thursday, October 1 at 10am
- For small business owners – some time in October
